"I was thrilled with the response to our first-ever Wine and Cheese Tasting event," said Clubhouse Manager Melissa Barnard. Held on Thursday, Nov. 6, the event was attended by approximately 250-300 people, and the feedback was universally positive.

The event created a wonderful opportunity to learn about and enjoy fine wines and cheeses in a relaxed, congenial setting. Bar tables were set up throughout the Hawthorn Room where folks gathered in small groups to enjoy each other's company. Soft jazz music played in the

at the governors' meeting



Oct. 23, 2025 Meeting

The October meeting of the RCAI Board of Governors was held at 9 a.m. in the Clubhouse Hawthorn Room.

Secretary Lori Moses called the roll. A motion was made to accept the Thursday, Sept. 18, 2025, BOG meeting minutes. The motion was seconded and passed unanimously.

President's Report

President Jolly thanked everyone for attending.

Treasurers Report

Treasurer John Craven discussed the financial reports for September, stating as of Sept. 31, the budget variance report has nothing outstanding to report. He then asked General Manager Tom Curry to present the first reading of the proposed 2026 budget.

2026 Proposed Budget (first reading)

Mr. Curry reviewed the budget summary sheet with the Board stating the current proposed increase to the RCAI 2026 budget was \$10.30 per unit per month, the new monthly RCAI carrying charge is proposed to be \$247.52. He then explained the layout of the detail sheets for each RCAI department. Mr. Curry presented a comparison table of the yearly assessment amounts as compared to inflation since 2019 and explained the carrying charge has not kept up with inflation. If it had, the current monthly charge as compared to 2019's carrying charge (\$198) would be \$8.48 more or \$256.00 per unit per month. He explained the two largest increases are liability insurance and the contribution to the association's reserve account for future repairs and maintenance to RCAI facilities. Mr.

Curry then discussed the RCAI reserve funding plan. He then explained the proposed fee schedule to be included along with the budget which codifies existing RCAI fees for services. A discussion followed regarding the possibility of a new fee for gate-opening bar code sticker replacements. The board rejected the idea. Board members asked several specific budget questions. Mr. Curry suggested Board members review the sheets and email any questions or concerns directly to him so he could research the answers and share the answers with board members. The budget will be voted on in the November meeting

Management Report

Mr. Curry stated the past month has been very busy for the administration department with multiple 2026 budget meetings for the mutual directors. Tom reported that the executive committee and management met with the maintenance department union and negotiated pay and benefits. He reported unit sales in September with nine condominiums and three cooperative closings. A total of 56 new gate opening bar code stickers were provided last month

Mr. Curry reported the Maintenance Department completed and billed 611 work orders in September and responded to 10 after-hour emergencies. They also completed three-unit water-line reroutes last month due to pipe leaks within the concrete floor slab. He mentioned that furnace services are available through the Maintenance Department.

Projects

Mr. Curry reported on several projects.

• Asphalt paving projects

have been rescheduled several times by the contractor. It is hoped that we will get the parking lots completed before the weather turns too cold.

- The concrete sidewalk/curb project in the mutuals is progressing well and should be completed in the next two weeks.
- A Board workshop has been scheduled for Nov. 6 at 10 a.m. in the Clubhouse Ballroom with FWH to explain the proposed Newport Way culvert project that will reduce the number of homes in the flood hazard area.
- Seven new trees have been planted around the Clubhouse to replace the six that had been removed.
- Comcast is installing a new fiber optic cable for the clubhouse for channel 26 which is currently not working. Residents should note that they can see the same channel 26 slides at https:// www.rcainj.com
- The Golf course has hired a new assistant pro.
- M3 Director Danehy asked about JCPL's smart meter replacement. Mr. Curry explained that owners who receive a letter from JCPL regarding a broken meter receptacle needing replacement must call their directors or the Maintenance Department. The new meter box receptacles are part of the building and owned by the mutual association.
- M7 Director suggested the new "no pets players only" signs installed around the edge of the golf course are too small.

Committee Reports`

Community Affairs Committee Chair Casper reported on a motion from the committee recommending the Board

Bits & Pieces

It all started with a drip. A slow, rhythmic tap from the bathroom tub faucet that grew louder in the quiet hours of the night. Paired with a toilet that ran like it was training for a marathon, my 1980s bathroom had officially crossed the threshold from quirky to problematic. What began as a minor annoyance soon became the catalyst for a full-blown renovation - a journey that would test my patience, my budget, and my creative resolve.

Finding someone to trust with my bathroom was no small feat. One national company quoted \$30,000 and promised to finish in three days. Tempting, but extravagant. Another contractor came in at half that price, but their vagueness raised red flags. I ultimately chose a local contractor offering a generous discount for cash. The catch? The work would take a bit longer, and I'd be responsible for sourcing most of the supplies myself. It was a compromise I could live with-more control over materials and a chance to infuse the space with my personal style.

The hunt for supplies quickly became a scavenger hunt through home improvement stores and online catalogs. Vanities were either prohibitively expensive or disappointingly flimsy. Luckily, I have a secret weapon: my vintage solid oak vanity set. With a little elbow grease and creative refinishing, it could shine again, anchoring the room with timeless charm by adding accent paint and new bird and twig drawer pulls and knobs.

Countertops presented another fork in the road. Quartz dazzled with sleek luxury, but my heart - and wallet - leaned toward practicality. My trusty Formica countertop had served me faithfully for 37 years and still looked great. Why fix what isn't broken? I chose Formica again, embracing its durability and retro appeal.

I envisioned a seafoam green palette, soft and serene, but the wallpaper hunt proved fruitless. Nothing quite captured the whimsical vintage vibe I craved. So, I pivoted: beadboard paneling on the lower half of the walls and ceiling would add texture and charm, creating a cozy, cottage-like feel, with rustic bird-themed wallpaper for the upper half. It wasn't my original plan, but it felt right.

The tub was out, and a walk

-in shower was in. I'm still on the lookout for the perfect shower pan—one with a nonslip surface that can rival the security of my beloved 570suction-cup Rubbermaid bath mat. Excuse me for being oldfashioned, but safety and comfort are non-negotiable, especially when making such a big change.

Luxury vinyl plank flooring rounded out the vision. It's stylish, water-resistant, and forgiving underfoot—a practical choice that doesn't sacrifice aesthetics. But now I need to find scatter rugs that won't hurt the floor's finish.

With only one toilet in the house, timing and coordination will be critical. Every phase of the renovation must be carefully planned to minimize disruption. Reviewing the contract line by line, I made adjustments to keep costs manageable without compromising quality. It was a delicate dance between aspiration and affordability.

The toilet will be set back in place each night. Phew!

This renovation has been a rollercoaster - exciting, exhausting, and occasionally overwhelming. But as the pieces come together, I can see the finish line. The dripping faucet and running toilet were just the beginning. A space will emerge that reflects my taste, my resourcefulness, and my resilience.

When it's all done, I'll step into my new bathroom, take a deep breath, and a warm shower, and smile. Merry Christmas to me. May all your renovations be merry and bright!



of Governors consider allowing guests at the pool in 2026. The matter is on the agenda as discussion.

New Business

Resolution 2025-32 Clubhouse Dogwood Room and Hallway Coat Closet

A motion was made to approve \$90,897 (\$82,634 + 10% Contingency of \$8,263) for the renovation of the Dogwood Room and hallway closet to be charged to reserve account 4110. The motion was seconded. After discussion and explanation of the work, the motion passed unanimously.

Resolution 2025-33 Authorization for Insurance Plan for the RCAI Union and Non-Union Employees with AmeriHealth Effective Dec. 1, 2025

A motion was made to approve RCAI offering Ameri-Health health care coverage for participating RCAI employees effective Dec. 1, 2025. The motion was seconded. After discussion regarding the choice of the provider, the motion passed unanimously.

Discussion Item: Allowing Guests to the Pool

Mr. Curry discussed the pros and cons of allowing guests to the pool. M7 Director Jensen asked about lifeguards. Mr. Curry presented a single bid from Candlewood pool as an example of the cost of full pool service, which would include lifeguards.

- M10 Director Sforza promoted the idea of allowing guests and hiring a full pool services company. M6 Director Muller raised concerns regarding future insurance costs.
- Resident suggested guards aren't needed.
- Resident reminded the board that they bought in Rossmoor with the idea that guests were allowed at

the pool.

- A resident raised concerns about what was legally required.
- A resident reminded the board that the pool is an amenity that used to allow guests.
- A resident suggested that insurance costs could go down if we had lifeguards and the Board could charge guest passes to cover their costs.
- A resident suggested that older residents have an emotional need to share the pool with their family, including children.
- M10 Director made a motion to hire lifeguards for the 2026 pool season. The motion was seconded 14-Yes, 4-No. The motion passed.
- M7 Director Jensen made a motion to allow guests with rules to be established by the BOG through committee. The motion was seconded and passed unanimously.

Directors Comments

M11 Director Archambault asked for volunteers to help with the annual Thanksgiving dinner delivery.

Residents Comments

- Resident asked about number of employees in the Administration office. Then she asked about the auditor's 2024 audit comment regarding golf cart leases. She then recommended staying with current vendors rather than switching due to cost.
- A resident raised concerns about the trash company collecting both trash and recycling into the same truck.
- President of the Jewish Congregation Club asked about the ability to bring outside residents to join the congregation and be allowed into the community as members. A long discussion followed.
- M7 Director Jensen made a motion to allow nonresidents entry into the community as members for religious services. The motion was withdrawn.

President Jolly stated after discussion he will have an answer at the next meeting after they confer with the association's attorney.

The meeting was adjourned at 11:05 a.m.

As with Phase I of the renovation project, space will be tight for a time and folks will need to be flexible. We appreciate your patience as these important upgrades take place.



Basic training was an eyeopener for the four Rossmoor veterans highlighted last month. Some went overseas. One served stateside. All played important roles in defending our freedom.

Wayne Slivenski (Airman 1st Class, U.S. Air Force) spent basic training at Lackland Air Force Base in Texas. "I became an Air Force cop," he said in a recent interview; and after his training, he was sent to a Strategic Air Command base in Massachusetts. "Some of us did regular police duties, you know, broke up fights in the barracks and stuff like that." There were B52 bombers that would be sent to Guam then to Vietnam. They would do repairs so the planes were always ready for the next mission. "I only spent eight months in the service because my father passed away and I was given a hardship discharge."

Mark Schreiber (2nd Class Petty Officer, U.S. Navy) went to boot camp in San Diego and trained with the Navy SEALs. He ended up on the aircraft carrier John F. Kennedy. "Living on a carrier is a little city on its own. There were 5,000 guys on the aircraft carrier; and there were not restaurants, but galleys and little stores. Surprisingly, you wouldn't think there is beer on naval vessels. But when you are at sea for a continuous 45 days, you get two beers." Their mission took them into the Mediterranean and later Mark was sent to Iraq. This was prior to the terror attacks on Sept. 11, 2001. "9/11 was the only thing that made me want to go back to the desert. I wanted some payback," Mark said.

For Roy Will (Specialist 5, U.S. Army), basic training was at Fort Dix, followed by a rude awakening down south. While at Fort Rucker in Dalton, Ala., Roy and some others went to the bus terminal. Above a drinking fountain and a toilet was a sign that completely shocked him. "Colored Only." "And, I said to myself, 'This stuff is real.' And, I said, 'I better get out of this place.'" And he did. That was 1963 in Alabama.

Later, Roy graduated from air traffic control school and was assigned to the 147 Medium Helicopter Company in Fort Benning, Ga., "for further travel to a restricted area overseas." In November 1965, "We got sent to Oakland, Cal., and boarded a ship and away we go ... free cruise to Vietnam." After their ship arrived in Vietnam. "I hear BOOM! They're throwing grenades off the ship because they're afraid somebody's going to try to sink the ship." And he thought, "What did I get myself into?"

A memorable moment happened during a day off. Roy and two others went to the zoo in Saigon. "It reminded me of the Central Park Zoo. We come up to the silverback gorilla, and he comes running and puts his back up against the cage. The gorilla wants its back scratched!" So, Roy obliged. "Somebody had to do it." Today, the veterans have a special nickname for Roy. They call him "The Zookeeper."

Ray O'Reilly (Lance Corporal, U.S. Marine Corps) graduated high school at age 17 and didn't know what he wanted to do. "The Vietnam War was going on, and I said, 'Why don't I go fight for my country?" He joined the Marines and went to Camp Lejeune for boot camp. "My drill instructor didn't like me as soon as he saw me, because I only weighed 121 pounds." Ray was told to eat two servings every time he was at the mess hall.

From there, he went to Camp Pendleton, then Okinawa, where they looked for volunteers to go to Vietnam.

Ray's hand went up. He was in logistics and would go from base to base working on inventories. In Da Nang, danger came knocking. "The Viet Cong were nice enough to lob some mortar shells into our base every once in a while. Four times we got rockets shot at us while I was in Da Nang. I'm saying, 'Did you really volunteer for this?"

But, the air base at Chu Lai was by far the most dangerous. The attacks started slowly. Then, a sudden barrage. "Rockets came in for about two hours. They knocked out about 10 airplanes and a bunch of helicopters and it was pretty serious. I said, 'This is war.'"

After his time in the service, Ray came back to the U.S. "The worst part about going home, people didn't appreciate what we did."

Well, we do, and we're so grateful.

A Week on the Amalfi Coast

My sister and I landed at the Naples Airport after a nine-hour flight from Newark on Sept. 19. Our nattily dressed driver drove us through the narrow, curving streets at high speed while skillfully dodging the Fiats, Citroens, and Vespas fighting for space enroute to the Grand Hotel Vesuvio. Our 20 -minute drive showcased the extraordinary beauty and wealth along the Neapolitan Coastline as well as the poor neighborhoods in need of investment.

From our hotel balcony, we could see Mount Vesuvio in the distance and the Borgo Marinari marina directly in front of us with boats maneuvering in and out of slips on the Bay of Naples. Behind the marina was the Castel dell'Ovo, a historic fortress. We stepped out the front door of our hotel onto the pedestrian walkway known as the Neapolitan Riviera. It was a blazingly sunny day, and we took our time taking in the sights.

After dinner at an outdoor cafe, we returned to our hotel and ventured to the Sky Lounge, the rooftop bar. A stunning panoramic view of coastline and Mediterranean Sea with Mount Vesuvio and the Isle of Capri as the backdrop greeted us. We enjoyed drinks while munching on plump, Sicilian butter olives, and taralli (savory circular biscuits).

We met our tour guides and fellow travelers at the hotel on Sept. 21. After an introductory talk on the history of Italy, we boarded a van for Pompeii, the village destroyed in 79 A.D. by the eruption of Mount Vesuvius. There, an archeologist took us on a two-hour tour. While fascinating, it was challenging to remain upright as the stone walkways were very uneven. More than a few tourists went down. I was pleased not to be among them.

That night we had dinner with our tour group at Ristorante Transatlantic, located inside the marina in front of our hotel. It was a fun evening with lots of wine. Afterwards, my sister and I returned to the Sky Lounge for a night cap.

The next day we boarded a hydrofoil (high-speed boat) to the Isle of Capri. We took convertible taxis to Piazzetta, the heart of Capri's pedestrian village, where extraordinarily high-end shops abound. We walked to Ristorante da Tonino. There, under the chef's guidance, we prepared a multi-course luncheon that we then consumed with libations from their extensive wine cellar.

Highlights of our tour included a trip to Anacapri where a massive storm knocked out power in the area as we were touring the historic Church San Michelle and which necessitated a treacherous earlier than expected return to Capri; a hike to Mount Tiberio to visit Villa Jovis from which Emperor Tiberius ruled the Roman Empire from 26-37 A.D.; a tour of an organic farm and restaurant on the Sorrento

Still Have Windows 10?

By now almost everyone should have heard that Windows 10 will no longer receive security updates. That, in basic terms, means that the longer you have Windows 10, the more susceptible you are to malware (malicious software). That could not only affect you but it could make your system a vector for spreading malware. You do have a few choices, some not as easy as others.

You can do nothing. Scammers will thank you. Normal users will not. Your computer could be a viral spreader, plus any email you send

could be infected. I doubt your family or friends will be happy to get infected by what they think is an innocuous email.

Go to settings and Windows update. If your computer meets Microsoft specifications it will tell you to update. If it does not, it should give you the option of paying \$30 for one year of updates.

If your computer is less than five years old, you can do an end run around Microsoft's policies using special software to load Windows 11. The two most used are Rufus and Flyoobe. Please search for how to update using these as I cannot tell

you to update an unsupported computer nor do I have the space to do so. One other method is to edit the registry. Do not even attempt to do that as you could end up with a nonfunctioning computer. Do keep in mind that an unsupported computer means just that. If you have a problem, you are on your own.

You can try a different operating system. There are many versions of Linux. One called Winux is supposed to look like Windows but Linux Mint is the most popular. Should you desire, you can download ChromeOS flex and convert your computer to

a Chromebook. There are issues with these, as Linux needs manual updating and ChromeOS flex does not allow downloads from the app store. Linux will, however, let you use some Microsoft apps using a special program called wine. Do note that all of these can be downloaded to a flash drive and run from that drive to see if you like them.

Totally confused? Afraid to try any of the above solutions? That brings us to probably the best option. Buy a new computer that has Windows 11 already loaded. Do not buy a refurbished one. Problem almost solved. Now you have to follow a fairly easy setup procedure that the computer will walk you through. When you come to the part where it asks for your Microsoft account, be sure to use the exact same account that you had on the old computer. One drive will synchronize and all of your documents and pictures will magically appear. Too pricey? The holidays are coming, now you know what to request.

No Place to Rest Your Weary Head

Let's return to a time when traveling across our country by automobile wasn't as easy as it is today.

At the beginning of the 20th century, if you wanted to travel more than a day's drive from home, you had a problem. There were no motels back then. If you didn't have a friend or relative with an extra bed living along your route, you had a decision to make.

Even if you could find a hotel outside of the more populated cities, it would come with nonessential amenities that you would have to pay for, when all you needed was a place to rest your weary head.

The only other options were to sleep in your car or pitch a tent in a field along the road — but how much sleep would you get? You may not be in the best condition to get back behind the wheel in the morning.

However, with the American people's desire to hit the road and explore our country, accommodations for traveling families would eventually need to be developed.

First came public auto camps, which were little more than clearings where you could pitch your tent. More modern campgrounds would soon spring up in the 1920s, offering picnic areas with running water and restrooms. These campsites started to decline in the 1930s and were eventually replaced by motels in the mid-1940s. Before then, you couldn't even find the word motel in the dictionary. It is a

blend of "motor hotel."

Although their spelling was slightly different, the first motel in the world opened 100 years ago this month, on Dec. 12, 1925. It was The Milestone Mo-Tel in San Luis Obispo, Cal., where you could get a good night's sleep for the reasonable rate of \$1.25.

Today, although we still have budget-friendly chain motels with no-frills accommodations, many others offer amenities and prices that approach those of hotels.

You can still find the small, one-story, privately owned motels reminiscent of the 1950s. Their amenities might be sparse, offering little more than a clean bed, toilet, and shower. Just be cautious if you're considering staying at one of these places. If it's off the main highway, isolated, and run by a quiet young man named Norman with overbearing, invalid mother, I would think twice. If you must stay overnight, vou should avoid using the shower, as it might turn out to be the most eventful shower of your lifetime.



THE HUMAN ELEMENT: AN EXTRAORDINARY ORDINARY LIFE By Susan Peters

The beautiful 90-year-old woman sitting quietly on the couch held a concerned expression. I had been requested by several Rossmoorites to interview her. "I'm not sure there is anything special about me to tell you," she said. "I don't have a title or a college degree." Then she offered, "I believe, however, I have lived the blueprint of the original American Dream."

Joan Tamburello Clayton is the only child of Sicilian immigrants who settled in the Tennent, NJ., area during the Great Depression. She spoke of her father with great admiration. She told me he had a limited education, but possessed an excellent work ethic and worked hard to provide for his family.

"He was a saver," she said, "I still remember the glass jar where we saved coins to buy our first refrigerator." She recalled how proud he was to be an American. Only English was spoken in their home.

Joan graduated from Jamesburg High School where she met her childhood sweetheart and married Bill Clayton at age 18. She believed their meeting was a fateful one, since they both were part of the overflow of

students sent to Jamesburg from their respective towns of Tennent and Monroe.

She worked for a time as a secretary for the A&M Karughesian Rug Company (known for the famous Gulistan Persian rug), as Bill pursued a degree at Rutgers University. They started their family, raising their daughter and two sons.

Originally built as a lumber company in 1890, Jamesburg Hardware and Appliance Store had been owned by Bill Clayton's uncle since 1923. Bill assumed ownership and operation of the company in the 1960s. "We juggled home and career responsibilities throughout that time in our lives," Joan said.

The store also became the oldest General Electric (GE) dealer in New Jersey. and still is. For a time, GE offered generous perks to their more competitive dealers; as a result, Bill and Joan won awards that allowed them to travel all over the world, she fondly recalled. Upon Bill's retirement, their two sons, Jeff and Gary, assumed ownership of the store.

In later life, "the golf bug hit," she admitted. "It became the center of our social life and we played Rossmoor, Peddie, and Forsgate." Although quite humble about her win, "it was a small group of golfers." Joan won the Ross-

moor Women's Golf Championship in 2004. The Claytons eventually purchased a condo in St. Petersburg, Fla., traveling to and from New Jersey.

Joan was married 67 years when she lost her beloved Bill four years ago. They raised three beautiful children, six grandchildren, and eight greatgrandchildren. "I've had my bumps along the way," she said, making light of several health scares.

At 90, she enjoys line dancing and art classes once a week at Rossmoor. She also continues to work on Wednesdays at the hardware store, doing some computer work and enjoying her sons and the customers.

"Life's been good to me so far," Joan acknowledged.

Don't Ignore Those Fruitcakes

If you didn't get to see Jim Wilson's play "Just Desserts," you missed a real treat and lots of laughs. Even the Players had fun; and when there was a mishap, the actors recovered so well that the audience was sure that was part of their lines. Congrats to Jim and the Players!

Aside from the play's good time and the refreshments, I was reminded of how much Ken and I really like fruitcake. In fact, my Southern family loved fruitcakes, and even after I became a Yankee, I cherished those Christmas cakes that other folks ridiculed.

Years ago, when I headed up the Women's Guild's annual bazaar, I made sure there were plenty of Claxton fruitcakes and South Carolina pecans to sell for the Christmas season. I probably bought more of the fruitcakes

than anyone else. However, today even finding a fruitcake in the local stores is difficult.

Often for the holiday season, one of my late husband George's Texas customers would send little fruitcakes, about the size of cupcakes, noting that the dark ones were soaked in Bourbon. We warned my mother, a teetotaling Southern Baptist, as she selected all the dark ones, but she insisted that the whiskey cooked out. We tried not to chuckle.

Mother usually baked fruitcake cookies for Christmas, but she unfortunately never wrote down her recipe. I've often wondered if that's because she used whiskey in her cookies. Luckily, I was able to find a Paula Deen recipe but, of course, made a few changes. Here is my version.

Fruitcake Cookies

3/4 cup sugar

1/4 cup unsalted butter, at

room temperature 2 eggs, whisked

1/4 teaspoon salt

1/2 teaspoon vanilla

1/2 teaspoon lemon juice

Culinary Corner

1/4 teaspoon ground cinnamon

1 1/2 cups all-purpose flour

2 cups mixed candied fruit 2 cups pecans, finely

chopped

Preheat oven to 300 degrees.

Cream together butter and sugar with an electric mixer. Add eggs, salt, vanilla, lemon juice and cinnamon and mix well.

Slowly add flour and mix well.

Fold in fruit and pecans and again mix well.

Drop by rounded teaspoons onto greased cookie sheets. Bake for about 25 minutes.

Remove from oven and loosen from cookie sheets. Store in an airtight tin.

Makes about four dozen small cookies





Rossmoor Community Association, Inc. Snow Policy and Procedure

POLICY

When a snow or ice event occurs, it will be the objective of RCAI to make reasonable efforts to ensure that the 17 miles of roadways and 43 miles of sidewalks within Rossmoor are passable for motorists and pedestrians as soon as possible, in a safe and efficient manner. The safety of Rossmoor residents is the goal of this policy.

PROCEDURE

When a storm is predicted, all equipment and supplies will be checked and staff as well as the snow removal contractor will be informed of the response plan.

Snowfall accumulations of **up to two inches** are handled by pre-salting the streets and carport lanes prior to the storm to try and prevent snow/ice from bonding to the surface. Salting of the streets and carport lanes will continue as needed. Depending on weather conditions and the forecast, typically, no further action will take place.

Snowfall accumulations of more than two inches, typically, require the initiation of the full snow removal operations as follows:

- 1. Pre-salting streets and carport lanes to prevent snow from bonding to the surface.
- 2. Plowing all main and secondary streets (see list of streets under "Priorities") continuously after an accumulation of 2" or more or as required by RCAI management.
- 3. Once the storm ends, separate crews and separate equipment will begin plowing lanes and carports; plowing perimeter and main sidewalks; plowing driveways and finally shoveling of the main, front entrance walks and stoops leading to the main entrance doors of the manors. Secondary walks and/or stoops on the sides or backs of manors will not be shoveled or treated with ice melt.

In a typical snow storm (2 to 6 inches of accumulation), it takes approximately 12 hours once the storm ends to complete the full snow removal operation. In the event of a major snow event (6 inches or more) and/or icing conditions, it may require more time to complete the full snow removal operation.

4. Once the full snow removal operation is complete, ice melt may be applied to perimeter and main sidewalks and the front entrances walks and stoops leading to the main entrance doors of the manors depending on accumulations, ice conditions, ground and air temperatures and the forecast for the next 24 hours. Reasonable efforts will be made to maintain the perimeter and main sidewalks and the front entrances walks and stoops leading to the main entrance doors of the manors and driveways after each storm and for the days to follow until the conditions clear, but it is impossible to be everywhere all the time. A full ice melt application takes approximately six hours and is not effective in lower temperatures and without sunlight. Secondary walks and/or on the sides or backs of manors will not be shoveled or treated with ice melt.

5. Reasonable efforts will be made to rotate the snow plowing schedule of driveways and carport lanes each storm.

Utmost caution should be used if residents must use the walkways during a storm and during the thaw/ freeze cycle that typically follows each storm until all the snow/ice has melted. Each resident should consider having a supply of ice melt or grit for their personal use.

COMMUNICATION Fire/Police/First Aid Emergencies 911

Upon notification of a pending fire, police or first aid emergency requiring emergency personnel, the snow removal staff/contractor on site will make reasonable efforts to clear the road, walkway and/or driveway in the area where emergency personnel require access prior to or simultaneous with emergency personnel arrival.

In those instances where there is no notification in advance, upon learning of the emergency and/or arrival of emergency personnel, the snow removal staff/contractor on site will make reasonable efforts to clear the road, walkway and/or driveway in the area where emergency personnel require

access.

Reasonable efforts will be made to keep residents informed during a snow emergency, but it may not always be possible.

RESIDENTS' RESPONSIBILITY

It is *imperative and* the responsibility of all residents to know and participate in the procedure by moving vehicles to ensure proper and complete snow removal from our streets, carport lanes, and driveways. Vehicles should be parked in residents' assigned carport spaces or garages. Second vehicles or guests' vehicles may be parked in the lower level of the Clubhouse park-

NOTE: Snow cannot be <u>removed and road salt or</u> ice melt cannot be applied in the area where a vehicle is left on a street, carport lane, parking space on a carport lane or in a driveway. Due to the nature of the size of the Community, the miles of roads and carport lanes and the number of driveways, the contractor cannot return and remove the snow or apply road salt or ice melt where a vehicle had been parked during the snow removal efforts.

It is incumbent upon each resident to be attentive to the surroundings and exercise

extra care for their safety when walking on exterior surfaces during periods of inclement weather. If it is absolutely necessary to drive during a snow storm, please drive slowly and give snow removal vehicles the right of way.

If residents, their guests or employees use an entrance other than the front entrance walk and/or stoop leading to the main entrance door to their manor, it is the resident's responsibility to remove the snow and treat the secondary walk and/or stoop for ice.

Snow removal is an arduous and time consuming task. Please be patient. It is best for residents to stay in the safety of their manors. Typically, bus service and most activities are cancelled during a snow/ice storm. For your safety, residents should not approach active snow removal equipment.

PRIORITIES

The safety of Rossmoor residents is our priority. Supervisory RCAI personnel are on site during snow removal operations to lead staff and the outside snow removal contractor to oversee procedures and respond to emergencies. All main and secondary streets and entrance gates will be plowed

continuously to provide emergency access. Sidewalks to the Club House and Meeting House are continuously cleared and the buildings remain open during snow/ice storms for residents use in case of power outages and/or loss of heat.

Residents with medical conditions that require outside treatments such as, but not limited to, dialysis or chemotherapy, must register with the Healthcare Center prior to a winter storm emergency to guarantee access for these appointments.

Regular medical/dental appointments, going to work, grocery shopping, filling prescriptions, leaving for vacation etc. are not considered priorities and staff will not respond to such requests.

Residents that return to the Community during a winter storm or during storm removal efforts is not considered a priority. Safe access to a resident's manor may not be possible. It is advisable to check with the North Gate prior to returning to be sure snow removal efforts have been completed.
